• National Disaster Resiliency – Iowa Watershed Approach Project Partner Updates

- Hydrologic Assessment update Dr. Allen Bradley, Iowa Flood Center
 Bradley provided an update on data generated by ACPF predictive modeling in priority subwatersheds of the English River watershed. This data will be available to the public through interactive maps in the future.

Schilling provided an overview of Iowa Geological Survey and the services they are providing watershed groups through the Iowa Watershed Approach project. Surine shared a presentation on defining geological characteristics of the English River Watershed.

- O Planning and Implementation workplans Jody Bailey, Project Coordinator
 Bailey presented workplans to the Board of Directors outlining planning and implementation
 objectives for the next 4 years of English River Watershed initiatives under the Iowa
 Watershed Approach project. The Project Coordinators will be updating the workplans
 routinely to keep the Board apprised of objectives met and upcoming deadlines.

 Bailey introduced John Clayton, a member of the volunteer-led Water Quality team for English River watershed monitoring and discussed project objectives. Data from each sampling event is available to the public on the website.

 Bailey shared information from Emmons and Olivier Resources regarding the status of programmatic environmental assessments (PEA). Draft PEAs were submitted to IEDA in August, and are available for a 30-day public comment period.
